Special Test Considerations

It is important to make your patients aware that some laboratory tests have special considerations associated with them. These can include timed collections, the need for scheduling in advance, or must be collected at a specific Blood Draw Lab Site. When a patient arrives at a site that cannot draw the ordered test due to a special test consideration, they must be turned away. Please refer to this list [Special Test Considerations](#) when advising patients as to how and when to have their specimen collected.

Here is a list of a few of the most frequently ordered tests with Special Test Considerations:

Blood Bank

The blood bank is now stocking **liquid plasma** in addition to thawed plasma in the UVMMC ED fridge. Liquid plasma is plasma that has **never been frozen and has a much longer shelf life** (26 days) than traditional frozen plasma (five days after thawing). We are adding liquid plasma to our inventory to help **reduce plasma wastage and improve costs**.

Liquid plasma is **only indicated for initial resuscitation** of patients with trauma or massive hemorrhage. Patients who require multiple rounds of a massive transfusion protocol (MTP) will receive thawed plasma with subsequent rounds.

Compliance

MEDICARE PRE AND POST PAYMENT PROBES:

Patient medical record documentation must support medical necessity for Medicare to cover services. The laboratory is your patient care partner and wants to provide accurate supporting documentation when submitting claims.

How Physicians Can Help

UVM Health Network Laboratory may request additional diagnosis and medical information from your office to document the billed services are reasonable and necessary.

Examples of appropriate documentation includes:

- A signed office note from a visit where the practitioner ordered a diagnostic or other service.
- For incident to services, a care plan written by the supervising physician or nonphysician practitioner.
- Lab orders for recurring tests to meet the specific needs of an individual patient.
- Documentation regarding the date of the service(s) and/or any prior progress notes.

AFB Testing to Resume for Vermont Practitioners

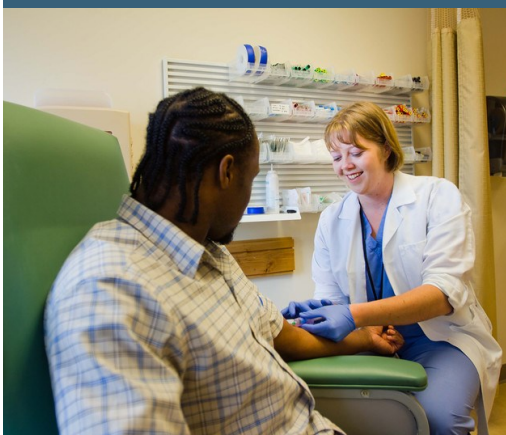
