INYANDIKO Y'ITEGEKO N'AMABWIRIZA: Mu kubahiriza amategeko ya IRS 501r, The University of Vermont Health Network – NY Partners izagabanya amafaranga isaba abarwayi bemerewe gufashwa muri Porogaramu yacu y'ubufasha bw'amafaranga ku kigero cy'amafaranga asanzwe asabwa abarwayi (AGB) bafite ubwishingizi mu kwivuza ku buvuzi bw'ubutabazi cyangwa ubundi buvuzi bukenewe. UBURYO BIKORWA:

1. The University of Vermont Medical Health Network, NY Partners izajya ibara buri mwaka amafaranga asanzwe asabwa abarwayi bafite ubwishingizi mu kwivuza, kandi igabanye ku rugero rumwe amafaranga asabwa abarwayi kuri serivisi zikwiriye gufashwa mu rwego rw'amafaranga. AGB izabarwa mu kwezi ku Ukwakira kandi izakoresheho kuri serivisi zose zitangwa mu mwaka w'ingengo y'imari.
2. UVMHN NY Partners izakoresheho uburyo bwo gusuzuma fagitire zo mu gihe cyashize mu kubara AGB kandi hazajyamo abishyura bo mu nzego za leta n'abikorera, by'umwihariko Medicare, Medicare ACO, Medicare Advantage ndetse n'abatanga ubwisungane mu kwivuza bigenga.
3. Dukurikije amabwiriza ya IRS, UVMHN NY Partners bagomba gushyiramo ibisabwa byose byemewe mbere y'umwaka w'ingengo y'imari, harimo n'amafaranga acibwa abarwayi. Fagitire zasuzumwe ni byo byishyurwa muri kiriya gihe cy'amezi 12, ntabwo ari serivisi zatanze muri kiriya gihe. Niba fagitire itarishyurwa kugeza ku muni wa nyuma w'igihe cy'amezi 12, ntabwo kizashyirwa mu mibare y'umwaka wingengo y'imari.
4. Iyo habarwa amafaranga yashyizwe kuri fagitire muri rusange, dushyiramo amafaranga yuzuye yemerewe na societe y'ubwishingizi hiyongereyeho amafaranga umurwayi azishyura. Ibi bikubiyemo ayo umurwayi yongeraho, ubufatanye bw'ubwishingizi ndetse n'ibyangabanyijwe.
5. Kugira ngo twemeze ko twakubiyemo ayo mafaranga yaciwe gusa cyangwa serivisi zemerewe kugabanyirizwa, UVMHN NY Partners izagabanya umubare wemewe hashingiwe ku kubura k'uburenganzira bwo gusaba serivisi. Aya mafaranga acibwa ntabwo yemerewe n'uwishyuye kandi ahindurwa ku rwego rusange rw'amafaranga mbumbe waciwe.
6. Imibare izaba ririmo amafaranga yose yemerewe n'uwishyura ubwishingizi, ukuyemo kutagira uburenganzira bwo guhindura imikorere bwashyizweho; aya mafaranga noneho agabanywa n'amafaranga mbumbe yagaragajwe kuri ibyo bibazo.

7. Kubara umwaka w'ingengo y'imari 2024 (1 Ukwakira 2023 - 30 Nzeri 2024) ni amafaranga ntarengwa agomba gutangwa ku bemerewe ubufasha bw'amafaranga:

- a. Champlain Valley Physicians Hospital: 64%
- b. Alice Hyde Medical Center: 44%
- c. Elizabethtown Community Hospital: 51%

8. Dukurikije itegeko rya leta ya New York, abarwayi bafite ubwishingizi n'abafite ubwishingizi bazahabwa igabanyirizwa ntarengwa hashingiwe ku mibare ya HFAL igaragara hepfo. Iyo bidasabwa na sitati, amabwiriza yacu azakoresha urwego rumwe ku bitaro uko ari bitatu by'abafatanyabikorwa, duhindurire abarwayi badafite ubwishingizi ndetse n'abafite ubwishingizi mu bitaro bitatu bya UVMHN New York.

200% - 300% FPL	Abarwayi badafite ubwishingizi: Igipimo cy'impuzandengo kigera ku 10% by'amafaranga yaba yarishyurwa kuri serivisi na Medicaid Abarwayi bafite ubwishingizi budahagije: Kugera kuri 10% ntarengwa by'amafaranga yari kwishyurwa hakurikijwe kugabana igiciro cy'ubwishingizi bw'umurwayi.
301% - 400% FPL	Abarwayi badafite ubwishingizi: Igipimo cy'impuzandengo kigera ku 20% by'amafaranga yaba yarishyurwa kuri serivisi na Medicaid Abarwayi bafite ubwishingizi budahagije: Kugera kuri 20% ntarengwa by'amafaranga yari kwishyurwa hakurikijwe kugabana igiciro cy'ubwishingizi bw'umurwayi.

9. Kubara urwego kuri AHMC, CVPH na ECH ku mwaka w'ingengo y'imari 2025 ni:

- a) Abarwayi bafite ubwishingizi bujuje ibisabwa bazahabwa inkunga zikurikira bashingiye kuri FPL (kugena abafite ubwishingizi buhagije ntabwo ari ngombwa kuko kugabanywa kurenza ibipimo bisabwa n'amategeko):
 - o <250% ya FPL ni igabanyirizwa rya 100% by'amafaranga abereyemo ubwishingizi
 - o <300% ya FPL ni 10% by'amafaranga yose asabwa nyuma y'ubwishingizi
 - o <400% ya FPL ni 20% by'amafaranga yose asabwa nyuma y'ubwishingizi
- b) Abarwayi bemerewe badafite ubwishingizi bazahabwa inkunga zikurikira zishingiye kuri FPL yabo
 - o < 250% ya FPL ni igabanyirizwa rya 100%
 - o < 300% ya FPL ni igabanyirizwa rya 98%
 - o < 400% ya FPL ni igabanyirizwa rya 96%

10. Mu gihe hamenyekanye bitinze ko umurwayi akwiriye gufashwa, kandi hubahirijwe gukumira ibihano by'ubukererwei, amavuriro yose azasubiza amafaranga yishyurwa arenze AGB ku burwayi bwari kuba bukiriye gufashwa mu gihe cy'iminsi 240 uhaye igihe ubusabe bwemerejwe. icyitonderwa, amafaranga arenze yishyurwa ashobora gukoreshwa ku yandi madeni ahari mbere yo gusubiza amafaranga umurwayi.
