TITLE: Extraordinary Circumstances – Disaster or Interruption of Patient Care

SUBJECT: Extraordinary Circumstances – Disaster or Interruption of Patient Care

POLICY STATEMENT: This policy addresses support for GME residents/fellows in the event of an “Extraordinary Circumstance” that significantly alters the ability of the UVM Medical Center and its programs to support resident/fellow education. Examples of extraordinary circumstances may include abrupt hospital closures, natural disasters, or a catastrophic loss of funding.

PROCEDURE:

1. It is impossible to anticipate every possible extraordinary circumstance or disaster that may be encountered and equally impossible to prepare detailed plans for incidents where the extent and nature of the event or condition is not known beforehand. Therefore, oversight is necessary to provide appropriate coordination, communication and decision-making, which will be provided by the DIO and GMEC in collaboration with the organization’s incident command team.
2. In the event of an extreme emergent situation affecting one or more programs, a declaration should be initiated by the affected Program Director(s) to the DIO. The DIO in collaboration with hospital senior leadership will make the declaration of extreme emergent situation, convene the GMEC as appropriate, and determine clinical duties, schedules, and coverage arrangements. Program Directors will remain in contact with the DIO about implementation of plans, additional resources if needed, and monitoring.
3. As quickly as possible and in order to maximize the likelihood that residents/fellows can complete their GME training, the DIO and GMEC will determine if transfer to another ACGME-accredited program is necessary.
4. Once the DIO and GMEC determine that the sponsoring institution can no longer provide an adequate educational experience for its residents/fellows, the sponsoring institution will, to the best of its ability, arrange for the temporary transfer of the residents/fellows to other ACGME accredited programs until such time as the UVM Medical Center is able to resume providing the training experience. UVM Medical Center is responsible for maintaining continuity of resident/fellow salary and benefits during temporary transfer.
 - a. Residents/Fellows who temporarily transfer to other programs as a result of an extraordinary circumstance will be provided with an estimated time for the relocation. Should that initial time estimate require extension, residents/fellows will be notified by their program director either by letter or email of the estimated time of the extension. UVM Medical Center is responsible for maintaining the continuity of resident/fellow salary and benefits during a temporary relocation.
5. The Closures and Reduction Policy (GME38) will be invoked if permanent transfer is required due to:
 - a. The extraordinary circumstance requires program reduction or closure due to inability of the sponsoring institution to re-establish adequate educational experiences; and/or
 - b. The extraordinary circumstance leads to significant reductions in clinical services in or closure of the sponsoring institution.
6. The DIO is the primary institutional contact with the ACGME and the Institutional Review Committee Executive Directors regarding extraordinary circumstances.
7. In the event of a disaster affecting other ACGME-accredited sponsoring institutions, the program directors at UVM Medical Center will work collaboratively with the DIO and GMEC to accept transfer residents from other institutions. This includes the process for GMEC approval and requests for complement increases with ACGME if needed. Programs currently under a proposed or adverse accreditation decision by the ACGME are not eligible to participate in accepting transfer residents.
